# IMPORTANT NOTICE TERMS AND CONDITIONS OF BOOKING THE ALL-IN EMPLOYEE RECOGNITION EXPERIENCE

THESE TERMS AND CONDITIONS MUST BE ACCEPTED BY YOU, THE UNDERSIGNED (HEREINAFTER REFERRED TO AS "YOU" OR "YOUR") AS A CONDITION OF SUCCESSFUL REGISTRATION FOR ATTENDING THE ALL-IN EXPERIENCE.

#### 1. PRICING AND PAYMENT

- (i) All participants who register prior to August 1, 2023, will be eligible for Early Bird pricing as set out on this website. All registrants after August 1, 2023, will be subject to the regular fees set out on the website. Both early-bird registrants and those registrants who register for the All-In Experience after the early bird deadline will be subject to the terms and conditions set out below.
- (ii) To register for the All-In Experience, you must register on or before January 5, 2024, and payment in the amount stated on website (the "Payment") must be received in full on or before January 17, 2024, in the manner described herein. Sandler in Calgary reserves the right to cancel your registration if full payment is not received by the due date. you register, you may arrange to pay the Payment either: (i) in one installment, which shall be due and payable on the date of registering for the All-In Experience; or (ii) two installments, with the first installment in the amount of \$1,500 plus GST being due and payable on the date of registering for the All-In Experience and the second installment in the amount of \$1,500 plus GST being due and payable on or before January 17, 2024, . ### 2. WARRANTY

(i) You acknowledge that you are not relying uponany warranties, promises, guarantees or representations made by Sandler in Calgary as it relates to the All-In Experience. All advertising material and other prior representations if any, whether oral or in writing are superseded by these terms and conditions. You acknowledge that the program content, attending speakers, presentation materials, and any other advertised components of the All-In Experience represented by Sandler in Calgary may be subject to change and that such change will not constitute a refund of Payment from Sandler in Calgary. You further agree that any such change or deviation of the All-In Experience program is not within the control or responsibility of Sandler in Calgary.

# 3. LIMIT OF LIABILITY AND RELEASE OF LIABILITIES

- (i) In no event will Sandler in Calgary be liable to You for any consequential, indirect or special damages including any loss of profits, loss of revenues, loss of business opportunity or loss of reputation associated with the All-In Experience. In no event shall Sandler in Calgary's liability to You for any claim brought by You or on your behalf be in excess of the Payment, (for clarity the Payment is the total price payable by You for successful registration for the All-In Experience), whether such liability is due to the fault, negligence, or strict liability of Sandler in Calgary.

- (iii) If any term or condition within this agreement is deemed to be invalid or unenforceable, such invalidity or unenforceability shall apply only to that term and condition and shall affect the validity or enforceability of any other covenant.
- (iv) Providing payment to Sandler in Calgary by MasterCard, Visa and American Express credit cards, electronic transfer of funds or cheque as forms of payment will by evidence of your acceptance of these Terms and Conditions whether such payment constitutes a partial payment or payment in full for the All-In Experience.
- (v) No waiver by a party of default, breach or non-observance in respect of any covenants, terms, or conditions of this Agreement will operate as a waiver of that party's rights under the Agreement.
